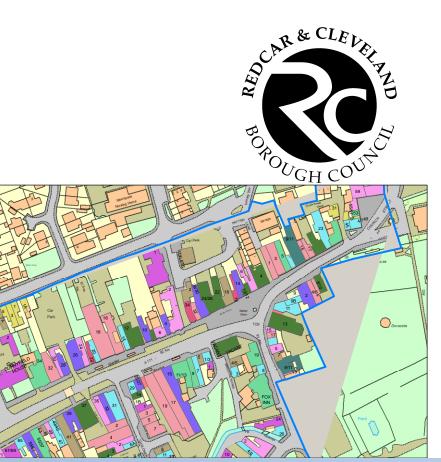
- Policy ED1 Designates

- Shared with other teams

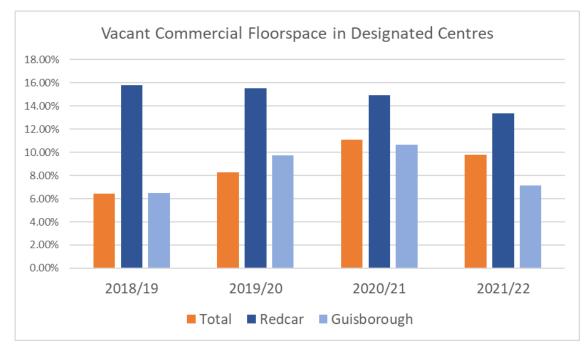

# **Changes Since Class E**



 Increase in total vacancy rate from adoption of Local Plan until 2020 followed by decline since 20/21.

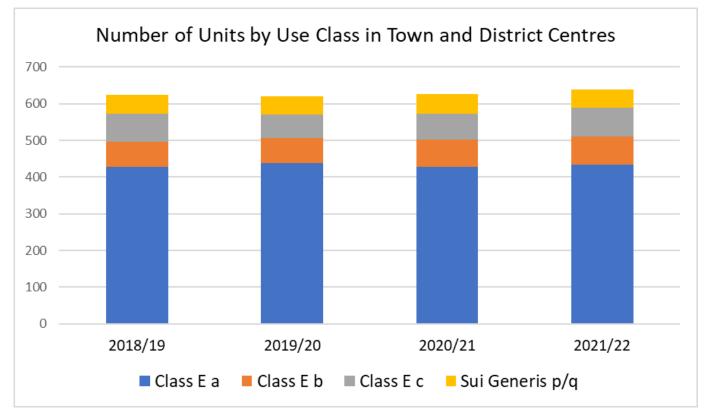


• No change with large vacant retail units but are seeing smaller vacant units becoming occupied.

# **Changes Since Class E**



• Slight increase in food and drink uses across the centres and some fluctuation in other uses.



## **Changes since Class E**



- Need further monitoring periods to understand if Use Class changes have led to this reduction and if it will be consistent.
- The objective of increasing adaptability and responding to changing consumer patterns aligns with the Council's objective for the centres.
  - In 2019, £29 million received from Towns Fund for Redcar.
  - In 2023, £15 million received from Levelling-Up Fund for Guisborough.

# Policy and Development Management Implications



- Local Plan adopted in 2018 so need to reflect changes in future review.
  - Policy ED1 in Local Plan identifies 2 Primary Shopping Areas
    - Redcar At least 71% of units retained for A1 (77.7%)
    - Guisborough At least 55% of units retained for A1 (51.5%)
- Limited number of new Class E applications so far. Have seen an increase in units changing to Sui Generis without permission, perhaps misinterpreting the Use Class changes.
- Conditions to restrict permissions to a specific Class E subclass have been used.
